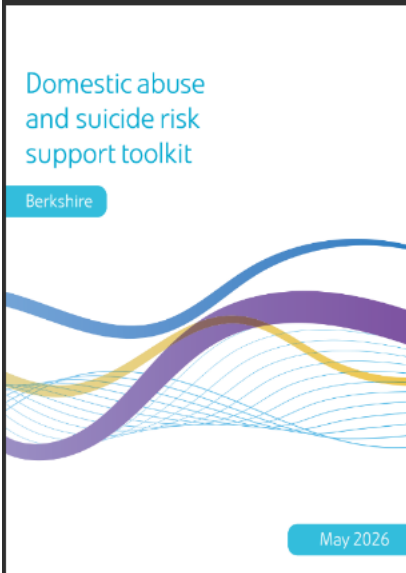

NEW USEFUL PUBLICATIONS, RESEARCH & RESOURCES

'Out of Sight, Out of Mind' - Imkaan

Imkaan has published a new research report, Out of Sight, Out of Mind, based on Freedom of Information requests submitted to all 42 Integrated Care Boards (ICBs) across England. The report shines a light on how specialist 'by and for' continue to be overlooked within local health systems and are too often not recognised, adequately funded, or meaningfully engaged with by ICBs.

Acquired Brain Injury (ABI): An invisible consequence of domestic abuse for women in the justice system – University of Exeter

Research by the University of Exeter and Brainkind identifies high levels of domestic abuse and associated brain injury among women in the justice system. Ninety per cent of women had experienced domestic abuse in adulthood; 78% reported non-fatal strangulation, and 80% screened positive for brain injury on a brief index, likely linked to abuse. Nearly 29% were care experienced. All care experienced women had attempted suicide and were more likely to have diagnosed brain injury, experience homelessness, and have other neurodevelopmental conditions.

'Keep it Football' campaign - Crimestoppers

The UK Government has published the latest Forced Marriage Unit statistics for 2025, offering insight into the ongoing work to prevent and respond to forced marriage.

Domestic abuse in pregnancy: expert insight videos - NSPCC

This series of expert insight films helps those working or volunteering with families and expectant parents to understand why the risk of domestic abuse can increase during pregnancy, how to spot the signs and respond effectively.

[Domestic Homicide Project – Vulnerability Knowledge & Practice Programme \(VKPP\)](#)

The fifth annual report from the national Domestic Homicide Project, which works across England and Wales, was published in April 2026. The report examines all deaths identified by police as domestic abuse related to improve understanding of risk indicators, victim and perpetrator demographics. The unique dataset collects detailed information on these deaths not available from any other source to help police and partners improve their response to domestic abuse, domestic homicide and suspected victim suicide following domestic abuse.

A joint briefing exploring the experiences of victim-survivors of domestic abuse with the Child Maintenance Service (CMS). Developed in collaboration with Surviving Economic Abuse, Women's Aid, and victim-survivors, it highlights serious gaps in support and safeguarding.

[Children and Young People Bereaved by Parental Domestic Homicide - A focus on the United Kingdom and Ireland](#) – University of Edinburgh

This brief report conveys key findings from the study "Children and young people bereaved by domestic homicide: Understanding home, relationships and identity", with a focus on the United Kingdom and Ireland. It complements the report focusing on the findings from the Australian phase of the study.

The five videos include insights on: what the voice of the infant is and why it is important; how practitioners can listen to the voice of the child and incorporate it into their work; and overcoming barriers to hearing the infant's voice.

NSPCC Learning has published new Talk Relationships resources to help schools engage parents and carers with the sex and relationships education (SRE) being taught, supporting them to talk to their children about healthy relationships. The resources include: a schools toolkit; an editable presentation; a guide; and five factsheets on specific SRE topics and how parents and carers can address them. NSPCC Learning has also published updated resources for a Whole-School Approach Framework, in line with the new Relationships, Sex and Health Education (RSHE) guidance for England.

[Rethinking domestic abuse in child protection: Strategic and Frontline Briefings - Research in Practice](#)

Research in Practice has published a suite of resources to support practitioners and leaders to rethink how they respond to domestic abuse and violence (DVA) in child protection. The resources draw on learning from the three year 'Rethinking abuse in child protection' project, and share findings on: how intersecting inequalities shape families' experiences of social care and how an intersectional understanding of DVA can be incorporated into service design and delivery; how whole person and whole family approaches can improve outcomes for families and children; and how to develop evidence-informed responses to DVA across social care. The resources include briefings for strategic leaders and frontline practitioners, along with case studies showing how local areas have applied learning from the project.
